#### S. William Becker

Bill Becker is the Executive Director of NACAA, the National Association of Clean Air Agencies, an association of state and local air pollution control agencies in 42 states, the District of Columbia, 116 metropolitan areas across the country, and 4 territories that have responsibility for implementing air pollution control problems under the Clean Air Act. He has served in this position since NACAA was founded in 1980. Prior to joining NACAA, Mr. Becker worked for the Congressional Research Service of the Library of Congress, and directed the environmental affairs departments for two national associations. He received a Master's degree in 1973 in Environmental Engineering from the Johns Hopkins University and his Civil Engineering degree from Syracuse University.

#### **Dallas Burtraw**

Dallas Burtraw is a Senior Fellow and the Associate Director of the Center for Climate and Electricity Policy at Resources for the Future. He has been a lecturer at the Johns Hopkins School of Advanced International Studies and a professor at Georgetown University. Dallas received his Ph.D. in Economics and MPP in Public Policy from the University of Michigan and his B.S. in Community Economic Development from the University of California, Davis. ### Joseph Goffman

Joseph Goffman is the Associate Assistant Administrator for Climate and Senior Counsel to the Assistant Administrator for Air and Radiation at the U.S. Environmental Protection Agency. He joined the agency in 2009, and has worked on the Mercury and Air Toxics Standards, the New Source Performance Standards for the oil and gas sector, the Carbon Pollution Standards for Power Plants, the Cross-State Air Pollution Rule, and related climate change and air quality rules. He is one of the senior agency officials implementing President Obama's Climate Action Plan. Prior to joining EPA, Joseph served as Majority Senior Counsel to the Senate Committee on Environment and Public Works (EPW), Legislative Director to Senator Joe Lieberman, senior attorney at the Environmental Defense Fund. As Associate Counsel on EPW and then as a section chief in EPA's Acid Rain Division, he played a key role in developing and drafting the landmark Clean Air Act Amendments of 1990 and the implementing rules. Joseph received his law and undergraduate degrees from Yale University.

#### **Judith Greenwald**

Iudith Greenwald is the Deputy Director for Climate. Environment, and Energy Efficiency in the Department of Energy's Office of Energy Policy and Systems Analysis. She has over 30 years of experience working on energy and environmental policy including fifteen years at the Center for Climate and Energy Solutions, most recently serving as the Vice President for Technology and Innovation. Judith coconvened the National Enhanced Oil Recovery Initiative, was a member of the Advisory Council of the Electric Power Research Institute, and has served on several National Academy of Sciences panels studying vehicles and fuels.
